He began his career in the public sector, first as a legislative assistant to U.S. Senator J. William Fulbright, then as an Attorney-Advisor to the Assistant Attorney General, and finally as a federal prosecutor, initially for the U.S. Department of Justice's Criminal Tax Section and subsequently at the U.S. Attorney's Office in the Eastern District of Missouri.

David has been a force in the St. Louis Community, serving on the Board of Directors of the Washington University Hillel Foundation, The Jewish Center for the Aged (President, JCA Associates), Congregation Temple Israel (Treasurer), Westwood Country Club (President) and The Anti-Defamation League. For over 30 years he has served as an adjunct professor of law at Washington University School of Law, teaching a course on tax fraud prosecutions in the graduate tax program. In his spare time, David teaches a photography class at Fanning Middle School in St. Louis City as part of an enrichment program administered by UrbanFUTURE.
