This closing will enable Edwards to focus his energies on his retained holdings, which include [Blueberry Hill and the Duck Room](#) (where Chuck Berry performed 209 legendary shows), [The Pageant Concert Club](#), [Delmar Hall Music Venue](#), [Moonrise Hotel](#), [Pin-Up Bowl](#), [Peacock Diner](#), and the soon to open Magic Mini Golf.
