

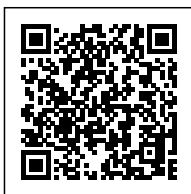
# CAPES SOKOL WELCOMES 2017 SUMMER ASSOCIATES

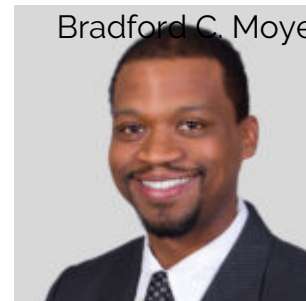

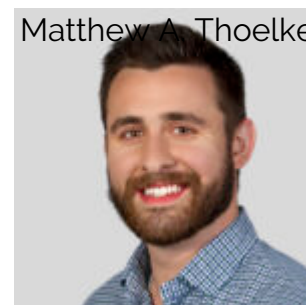
