On Thursday November 2<sup>nd</sup>, [John S. Meyer, Jr.](#), Capes Sokol Shareholder, addressed an audience of over 300 members of the Washington University Law School community at the WashU Law Scholars in Law Dinner. The annual event honored scholarship recipients and their donors.
